

Public Notice of Perpetual Memory and Testimony

Notice to all agents and officers of the de facto corporation masquerading as organic Government.

"Per my Lawful Counsel, i: living soul, flesh and blood natural woman (Genesis 1:26-28), retain all my Rights given to me by Nature and Nature's God/ "Creator" as granted by Natural Law, and described in the bible: Genesis 2:7 "man has dominion over the Earth" which was codified October 1776, "The Declaration of Independence (1776)", "The Constitution for The United States of America (1776), and through the Supremacy Clause of The Constitution of the United States (1787) under Title 28 USC 3002 15 (A) the United States is a federal corporation not a federal government, Sixth Amendment: sections 1,2,&3, Seventh Amendment's Constitutional provisions assuring a common law Court and speedy trial by jury "of my peers", First Amendment protects the freedom of religion and that means the freedom to be let alone, and not forced into association with the American BAR Association, a religion of the CIVILLY DEAD, as i am not a STATANI\$T and do not pray to SATUTES, nor do I wish to partake in religious ceremony wherein the civilly dead also known as "capitus dominitio maxima" is Summoned by way of a priest/judge/warlock of a "Civil Society", of which I am not an associate, nor wish to be associated with, and demand that your Roman Curiae- BAR members- Cease and Desist any and all contact with me, and I demand you get out of We The People's Courthouses within 30 Days of receipt of this Notice.

81st Congress section 3123: "The American BAR Association is an International Criminal Syndicate of the Communist Party", and are dishonorable according to their own Cannon Laws; for which I do not subscribe nor bow to. According to the Law reserved by "The Declaration of Independence" "I cannot give my Rights away even if I wanted to!" "Articles of Confederation of this Perpetual Union", "The Northwest Territories", "The Universal Declaration of Human Rights", "The international Covenant of Civil and Political Rights", The Law of Nations, as it observes all "Treaties" signed (upon the American Continents), the aforementioned are Supreme Law. Once these Treaties are brought to your attention, you must obey them, or face the consequences.

There is no acceptance by me of any presumptions or assumptions of my status, standing, and jurisdiction, or venue, and above all are hereby retained, and are a Court of Record retaining my Declaration of "Right of Self-Determination", and expressed Irrevocable Living Trust. I do not consent to anything; I will not sign anything. We have no contract, and there will be no tacit procuration of agreement by me being a citizen, person, or resident. As I am not, nor am I a U.S. citizen, as I have taken no Oath of allegiance pursuant to your corporation's Statutes At Large Volume 2 Statute 153, C.P. 28, 1; Rev. St. 2165. My "Court of Record" reflects my standing as "one of the People"/"We The People" as i was born free upon the land currently known as Pennsylvania, my status is that of Pennsylvanian/state Citizen, with limited diplomatic immunity, in no uncertain terms and with clear and convincing evidence which stands upon the Court of Record and is lawful notice, which cannot be adjudicated, only witnessed, as i am the named beneficiary and executor of the Trust, which is created by way of "Constructive Fraud" by these Corporate Communist\$ known as BAR Association. (See: 81st Congress section 3123)

As per the original ratified 13th Amendment – "No Titles of Nobility" and the United States, Title 18 section 242 & 241, you are treasonous and may be hung at high noon till sundown in the court-square for operating under the color of law, and your attempts to deprive me of my rights, will not be tolerated!

If you came with another, Title 18 section 241 applies. If you continue, I will be forced, by you, to file criminal charges against you personally in your private capacity, i may sue State or local officials for the deprivation of any rights and privileges or immunities secure by the constitution and federal laws. Under *Bevins v. Six Unknown Agents of Federal Bureau of Narcotics*, 403 US 388 (1971), i may sue federal officials for the violation of certain Constitutionally protected Rights, and or make a Citizens' Arrest, and or protect myself by way of self-defense. I will not submit, associate, be subjected, contract, or consent to any officer, agent, or order from **any administrative court** or military tribunal, and will treat them equally, as I would any other trespasser. The only Rule of Law is the national Constitution, for which you took an oath to uphold. So, unless you have a signed and sealed warrant from a constitutional Article I or Article III Court that clearly states its exact purpose, place, and thing, to be searched or seized, and is backed up by a sworn Affidavit or Sworn Testimony given under Oath and Affirmation and Under the Pains and Penalty of Perjury, leave! I hereby stand by the Fifth Amendment and reserve my Right not to incriminate myself and remain silent upon unlawful questioning by an officer of the executive branch, or a corporation. Now leave here and let me be, immediately!"
