Kate Brown will be personally liable and responsible to pay the penalty should the DAS Risk Management not pay the penalty.

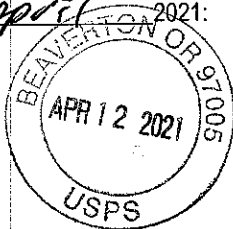

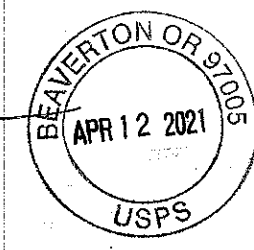

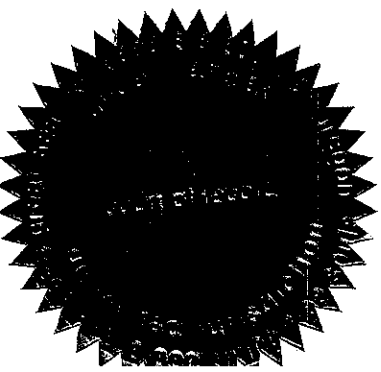
